CLOSE TO PUTIN

Ozero (Lake) dacha cooperative is the most famous microgroup related to Vladimir Putin. This year it is going to celebrate its twenty-year anniversary. Dacha consumer cooperative "Ozero" (Lake) was registered on November 11, 1996 by Priozersk division of the Leningrad region Register Chamber.

The lake in question is Komsomolskoye Lake in Karelia, named after Komsomol, the mass youth organization in the Soviet Union, which was wholly controlled by the Communist party. Till 1948 its name was Kiimajärvi (Finnish Karelia was ceded to the Soviet Union following the Winter War of 1939-1940). It is fed by the river Pionerka (Pikojoki in Finnish), the name meaning a female member of the Soviet schoolchildren organization. Konnitsanjoki, now the Gay (Veselaya) river flows from the lake. The plot belonging to Lake cooperative is fenced, preventing access to the shoreline in violation of Russia's law.

Water Code of the Russian Federation

Article 6. Public water bodies

- **1.** State- or municipality-owned surface water bodies are public water bodies, i.e. publicly accessible water bodies, except as otherwise provided in this Code.
- **2.** Every person has the right of access to public water bodies and can use them free of charge for personal and domestic needs, except as otherwise provided in this Code and other federal laws.
- **6.** The strip of land along the shoreline of a public water body (shoreline strip) is for public use. The width of shoreline strips of public water bodies is twenty meters except for shoreline strips of canals as well as rivers and streams which are not longer than 10 kilometers measured from the outlet to the mouth. The width of shoreline strips of canals as well as rivers and streams which are not longer than 10 kilometers measured from the outlet to the mouth is five meters.
- **8.** Every person has the right to use (without any motor vehicles) the shoreline strip of public water bodies for moving along or staying at such water bodies, including for amateur or sport fishing and mooring watercraft.

Yury Kovalchuk's brother Mikhail is the president of Kurchatov Institute of Atomic Energy. He was a driver for setting up Rosnano state corporation.

The Regional Foundation for Scientific and Technical Development where **Andrey Fursenko** was the CEO had been co-founded by the St.Petersburg administration represented by its committee for managing the city property (the chair of this committee was deputy mayor Mikhail Manevich murdered on August 18, 1997), the state Foundation for Furthering Development of Small Businesses in R&D, the Foundation for Regional Development of St. Petersburg, Bank Rossiya, Association Russian House of International R&D cooperation, Svetlana plant (a Soviet manufacturer of electronic components) and Granit (a Soviet R&D center).

Rudolf Ritter, a co-founder of SPAG and a brother to former vice prime minister of Liechtenstein, was arrested in May 2000 on charges of money laundering and links to organized crime (however, he was acquitted on both counts and convicted only of petty fraud – he embezzled funds totaling 300,000 Swiss francs).

Sergei Fursenko was the president of the Russian Football Union and UEFA Executive Committee in 2011-2015.

Lake, meaning the dacha cooperative with wooden dachas and all, is still alive and kicking, but its original founders mostly left. From its founding fathers only **Vladimir Smirnov**, **Nikolay Shamalov** and **Vladimir Yakunin** remain.

AB RUSSIA

Most members of Lake have been somehow related to dealings of a bank named Rossiya/Russia (it is also known as ABR, AKB Russia, AB Russia and even as Russia Bank - not to be confused with the Bank of Russia, Russia's Central Bank).

The present AB Russia is a descendant from a mutual commercial bank Russia established in 1990 with the participation of the Leningrad regional executive committee of the Communist party, or obkom (St. Petersburg was renamed Leningrad, after Lenin, first head of the Soviet state, in 1924 and reverted to its old name in 1991). Its first CEO was Arkady Krutikhin, chief of the staff at the Leningrad obkom. After the attempted coup against Soviet president Mikhail Gorbachev failed in August of 1991, this Communist party bank was transformed into AKB Russia due to assistance from the reformist Leningrad/St. Petersburg mayor Anatoly Sobchak. AKB Russia was registered on December 29, 1991.



This note, dated April 6, 1991, says that the Soviet Communist Party Central Committee approves the allocation of 50 million rubles from "the party insurance fund" to the mutual bank Russia.

In 1996 capital of AB Russia amounted to 11,184,267 thousand old rubles (1000 old rubles became 1 new ruble in 1998); for comparison, Sberbank's capital at the moment – Sber was then, as it is now, the top Russian Bank – amounted to 6,099,889,000 thousand old rubles. It was a small regional bank; with assets totaling 22,389,289 it was nowhere near the top 100.

As of January 1, 2016, capital of AB Russia amounted to 547,311,800 rubles and with assets totaling 510,275,762 thousand rubles it was 16th bank in Russia.

According to official data as of February 2016, **Gennady Timchenko** was a Finnish citizen residing in Switzerland. In 2014 Timchenko was worth \$15.3 billion.

Sergey Roldugin is the godfather to Maria, Putin's elder daughter. He is a well-known cellist and presides over the St. Petersburg House of Music. His brother Yevgeny has been Gazprom's representative in Riga, Latvia.

Mikhail Shelomov's mother was Liubov Shelomova, a cousin of Putin.

Ivan Mironov has a stepbrother Kirill Selezniov who sits on Gazprom's Board as well as on the Board of AB Russia. Kirill's father Gennady Selezniov (1947-2015) was the speaker of the State Duma, Russia's lower house, from 1996 to 2003.

Svetlana Krivonogikh owns Leningrad Center in St.Petersburg. The venue, earlier used as a movie theater, was renovated by Ricardo Bofill in 2015.

Tatiana Svitova's mother Yelena was a vice president of Gazenergoprombank. The bank has been servicing gas suppliers within Russia. It was bought by Yury Kovalchuk and merged into AB Russia.

Dmitry Gorelov, president of Petromed holding, has been member of the Board of AB Russia till 2012. He was a business partner of Shamalov (Lake) in UK Modul, a St. Petersburg-based company.

Andrey Katkov chaired the Board of AB Russia in 1998-2004. He and Gennady Timchenko were business partners in Kinex, an oil trading company. Now he co-owns Sillamae Sadam AS (Sillamae Port) in Estonia.

Yevgeny Malov was another business partner of Timchenko in Kinex. He co-owns Andersen Hotel in St. Petersburg with **Viktor Myachin** (Lake). He co-owns Sillamae Sadam AS (Sillamae Port) with Katkov and Tiit Vahi, head of the Silmet Group and a former Estonia prime minister.



On June 23, 1998, in St. Petersburg, two AB Russia shareholders, Gennady Timchenko and Andrey Katkov founded a foundation under the name Sports Judo Club Yawara-Neva. Arkady Rotenberg, who was once a judo sparring partner of Putin's, became its director general. Vladimir Putin is, of course, the club's honorary president.

Prosperity of Lake members, their friends and relations has been slightly marred by personal sanctions imposed on some of them in 2014.

Some entities controlled by members of Lake, for instance, AB Russia, SMP-Bank, Stroygazmontazh and Transoil were hit by sanctions. In their trouble they were relieved by the government contractors. For instance, according to Forbes Russia, in 2015 Rotenbergs' Stroygazmontazh got 426 billion rubles in the government contracts, without tender.

twenty years Lake cooperative expanded and turned into a huge financial and industrial empire. Its founders did not parted ways. They established a mighty network consisting of public officers, prominent billionaires as well as of persons hidden for now from public eye. Most prominent persons within this network, besides Vladimir Putin, are ultra rich Gennady Timchenko, the Rotenberg family, Yury Kovalchuk and Kirill Shamalov. They feed upon the state sector of the national economy, the government contracts and deals involving assets from the state-controlled corporations. Links of Lake people with state corporations such as Gazprom, Rosatom and Russian Railways are obvious. Still, there are plenty of more secretive persons and of less clear links.
